We will be anxious to hear your comments, the ways in which your expectations of wrestlers, your officiating style and personal mechanics change!

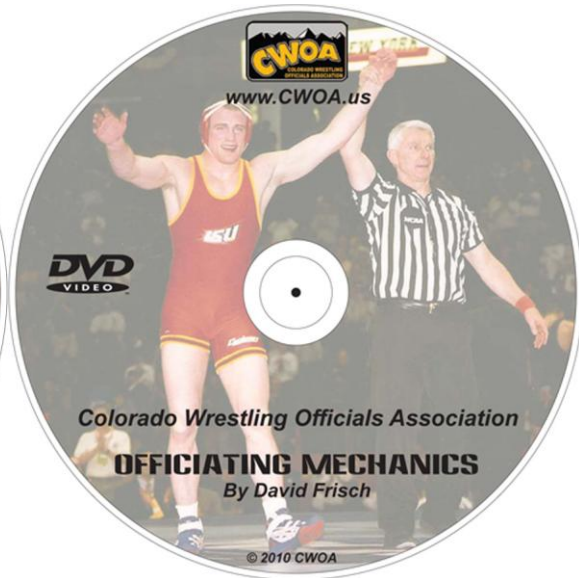
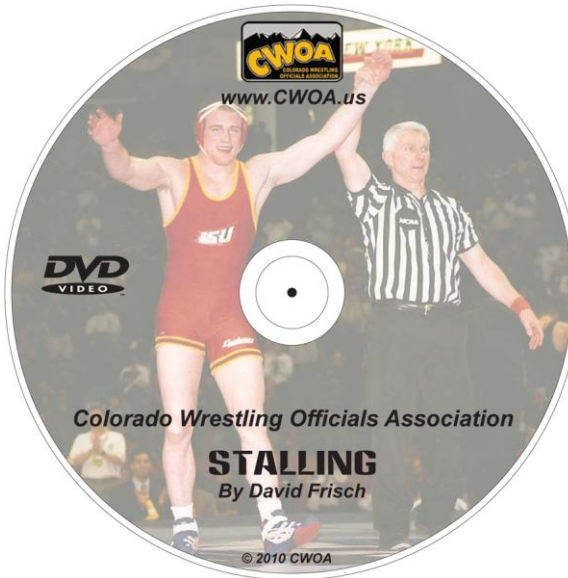
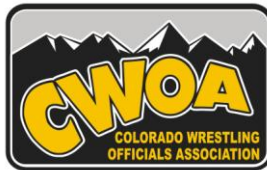
